Have a Happy Holiday and a safe and prosperous New Year.

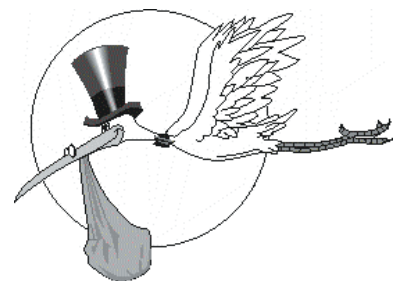

The year 2008 in review:

This year for the Belle Terre Community Association has been both challenging and rewarding. We completed another banner year with events like the football play-offs, pancake breakfast, children's egg hunt, safe boating class, Fourth of July party on the beach, and residents' party. The weather was with us again for the second annual lobster bake and the food, company, music, decorations, and bon fire really topped off the night. The BTCA also played an important role in the reconstruction of the entrance wall/gates and orchestrated a rewarding and memorable dedication ceremony.

Other activities we took on during the course of the year were to begin collecting financial data from the events and activities, so that we can start budgeting year after year. To our Belle Terre Community, the Belle Terre Campers and Staff,

This is a long overdue letter to our community and the members of the Belle Terre Camp Program. Why so long? I have thought long and hard about thanking all of you for your continued and generous support to Andrew's Memorial Scholarship Fund, and in my mind I have. It has been difficult to put into writing but it needs to be done so all of you know how appreciative we have been all these years. I know for a fact that the students who have benefited from the scholarship fund are appreciative as well.

It is hard to believe that it has been 7 years since our son Andrew, Brad from the camp program and Denise Abelson, the camp director left us. Not a day goes by that we don't think of them. It is all bitter sweet. Our family is reminded every day of the years that have passed as we see Andrew's friends mature into adulthood and are now graduating from college. They will be starting lives of their own and we often think about what Andrew would be doing now.

You know the old saying "Out of sight out of mind". For all of us who have had losses, then and now, the saying is not true. All of our passed loved ones have left their mark on us and their community. I know Andrew's friends lives were changed forever when they lost their good friend. For many of them, it was their first experience of losing someone they truly loved. It broke my heart to see their pain. We were all a tremendous support for each other. In fact, I was overwhelmed by the support from them and our community. It is essential for the healing process. As tragic as Andrew's loss was, I never felt alone.

Life today is so complicated but one thing never changes and that is that life is fragile. It can change in the blink of an eye. If we have learned anything, we have learned that every day is a gift and we need to make our days count. It is so important to be patient, kind, giving and supportive to those who need it and to those who don't. The movie Pay it Forward was so sad,

but the message was clear. It is important to slow down and enjoy life. We really can't lose sleep over spilled milk, literally. I can't tell you how many times in a day that I see a situation where I wish I could say to people, get a life.

Andrew's Memorial Scholarship Fund was set up to honor his love for art and music. It is available to the students in grades nine through twelve at the Port Jefferson High School. Two scholarships are given each year in the amount of \$500.00, one to an art student and one to a music student. All of your generous donations have stayed in our school district and to date, 16 scholarships have been awarded. Two scholarships in the amount of \$2,500 were awarded to students from Andrew's graduating class. The other scholarships went to students who participated in programs such as the summer music program at Julliard in New York City, the Stony Brook University music program and Johns Hopkins summer art program. Other students used the scholarships to pay for their tutors over the summer months and others to pay for art programs provided on Long Island. We have received many wonderful letters of thanks from these students and their families. It is wonderful to be able to help students further their music and artistic ability. I know in my heart that Andrew would be so happy.

I can't thank you enough for your support over the last 7 years and I ask you to continue supporting the available scholarship funds in our community. They provide such wonderful opportunities for our children and continued support for their many talents. Our children are so precious to us and to our community. We are truly blessed.

The Wall Story

The Wall in Disrepair

It all started in September 2004 when Belle Terre historian Nancy Orth wrote a letter to Mayor Ted Lucki. She pointed out that the wall by the Gatehouse, the very symbol of Belle Terre, was “bereft of any maintenance” and “in a sad state of disrepair.” She asked the Mayor to embark on a project to restore our Belle Terre landmark to “its original architectural splendor”. Unfortunately, the original wall was not able to be repaired or restored, and an entire new wall had to be constructed. Mayor Lucki and the Board of Trustees, in conjunction with the Belle Terre Community Association, launched a four-year project to make Nancy’s vision a reality.

Building the wall to its original specifications was a complex operation. Funds had to be raised. The historical designs had to be authenticated. Construction plans had to be drawn. The historic materials had to be located and purchased. A bidding process to choose contractors had to be established. The construction had to be managed. After all this, landscaping and lighting had to be installed.

Fundraising

The Belle Terre Community Association spearheaded the fundraising. Joanne Cornell, Nancy Orth and John Heide led this effort which began with John Heide’s designing and producing an attractive brochure that was mailed to all the residents. In October 2005 a grand kickoff cocktail party was graciously donated by and hosted in the home of Robert and Kathy Frey.

This event was attended by a significant number of Belle Terre residents. This first round raised \$51,275.25 in donations. We were very lucky to have our New York State Senator Kenneth LaValle procure two New York State historical grants, totaling \$85,000, for the wall project. A second round of fundraising was completed in 2008 bringing in an additional \$27,905. The great efforts of the fund-raising committee amounted to \$164,180.25.

The Wall Committee

This whole process was expertly executed by a volunteer committee of nine members: Joanne Cornell, Robert Lofaso, Grant Geelan, John Heide, Dave McAnaney, John May, Nancy Orth, Bill Raso, and Bob Sandak. The committee first met in November 2006. During the project the committee met over forty times, with meetings frequently lasting up to two hours. In addition to all formal meetings, the members put in hundreds of additional hours performing individual tasks. Many of them sacrificed work hours and adjusted their schedules to attend the meetings.

Planning

To accomplish the overriding goal of recreating the original wall, the late John May, architect and Belle Terre resident, worked at creating the construction plans. The meticulously drawn final design was approved by the committee. One of the biggest challenges was finding the specified bricks. The company that had made the original bricks had gone out of business in 1911, and it was impossible to find “readymade” bricks of the proper size and color. The committee located a company in British Columbia, IXL Brick Manufacturers Inc., that could supply bricks that closely matched those on the original wall. These were shipped across the country from Canada. Next, the ornamental iron work had to be specified for custom replication and fabrication. Finally, a manufacturer had to be located to construct the specialized pier caps. David Kucera Inc. located in Gardiner, New York, was chosen to replicate the pier caps to original specifications.

Construction

Construction commenced on May 10, 2007, with committee member Dave McAnaney chosen to be the “on site” construction manager.

The first task was to remove the existing wall. The Village was very lucky to have Belle Terre resident Vincent Parziale donate the demolition and removal. Heavy equipment was needed to remove the old wall and the huge tree stumps behind it.

Before any work could be started, professional surveyor Harold Tranchon staked out the wall’s radius and pier locations. Next, concrete footings were poured by the Cutrite Landscaping Company.

Care was taken to maintain the exact curvature of the original wall, and the piers were placed in their original location. Umanzor Construction Company bricked the front and back of the wall. P.K. Creative Metals manufactured the wrought iron sections, each so heavy that it had to be lifted into place by a crane.

Finishing Touches

After the construction phase was complete, Belle Terre residents Chip and Kathy Cleary designed and installed an extensive shadow lighting system that casts beautiful highlights on both the wall and Gatehouse. In addition, Belle Terre resident and electrician Philip Buonomo provided outside wiring to power the shadow lighting.

A committee headed by Nancy Orth planted eighty rhododendrons on each side of the main entrance. On two cold March days, volunteers including Grant Geelan, Greg Geelan, Pat Geelan, Sheila Knapp, Nancy Orth, Bill Raso, Bob Sandak, and Pat Stockdale planted the 160 shrubs.

Belle Terre resident Lorraine Doganieri spent many hours stripping paint from the centuries-old eagles that adorn the central entrance columns. The pair of eagles, male and female, was brought over from England by George Washington Hill,

president of the American Tobacco Company (Lucky Strike Cigarettes) for his Irvington, New York estate. The Belle Terre Garden Club purchased the eagles from the estate in the early 1950's. The eagles have been stripped, primed, restored and returned to their original places with new custom mountings.

As a gift to the village, local landscaper Greg Van Ostrand, owner of Villagescapes, generously offered to design, plant, and maintain a variety of shrubs and ground cover surrounding the wall and Gatehouse.

Finally, sod was installed thanks to the generous donations of Belle Terre residents Louis Bove and Anthony Gitto. This final touch is not just grass, it magnifies and showcases the grandeur and beauty of the project.

Conclusion

The great story of the wall reconstruction is a product of the talent and generosity of the people living in Belle Terre. Many, many residents worked together to restore Belle Terre's entrance to "its original architectural splendor."

We owe them a great debt of gratitude. The tireless efforts of these skilled people have made the wall restoration possible.
