- Mayor explained the reasons for the motions presented for tonight's meeting.
- The fall bulk trash pick-up is scheduled for the week of December 9
- Road paving projects have been completed
- Code changes like the ones passed at last month's meeting do not become law until filed with the NYS Dept. of State.

#### V. COMMISSIONER'S REPORTS:

- **1. BEACH:** The Village thanks resident Jeff Brett, owner of King Quality, for replacing the roofs on the gazebo and beach buildings at no cost to the Village.
- **2. SIGN COMMITTEE:** Several samples have been obtained for the No Soliciting/No Trespassing signs.
- **3. CONSTABULARY:** September had 30 calls for service, 9 of which were emergencies. There were 62 summonses issued and 269 house checks.

- **4. Motion** by Trustee Musto, seconded by Trustee Engelhardt to pass a resolution giving the Mayor authority to sign a snow removal contract with Suffolk Snow Services, Inc. upon approval of the Village Attorney. Motion carried.
- **5. Motion** by Trustee Engelhardt, seconded by Trustee Musto to accept the resignation of Scott Accardo as alternate member of the Planning Board. Motion carried.
