### IV. MAYOR'S REPORT:

- Tonight is our annual organizational meeting where we appoint the commissioners who
  will serve for this fiscal year. We acknowledge the loss of Trustee Sheila Knapp and
  have appointed Jim von Oiste to replace her as Trustee and Beach Commissioner. Trustee
  Jackie Gernaey will take her position of Deputy Mayor. We also welcome newly elected
  Trustee Richard Harris.
- We are moving ahead with plans to make our Village more handicap assessable, especially at the beach.

### V. COMMISSIONER'S REPORTS:

- **1. BEACH:** Commissioner von Oiste thanked Youth Program Samantha Abelson for her help in getting the beach up and running. A recent storm caused some damage to the cabana area, but everything has been repaired.
- **2. BUILDINGS:** Commissioner Harris took a tour of the Village barn and will work with Beach Commissioner von Oiste to better organize the cabana storage. He also notice repairs are needed to the roof and siding.
- **3. PARKS:** Commissioner Musto reported our handyman is taking care of replacing the broken Plexiglas dome on the playground equipment. He will also be ordering more mulch for the equipment area.
- **4. ROADS:** Commissioner Solo reported the paving of three roads, Nonowantuc, Arbutus and Intervale, is complete. Recent heavy rains took out a portion of Northwind Drive making it dangerous for residents or emergency vehicles. Mayor Sandak declared a state of emergency, and repairs were made to make the road stable, while work can be scheduled to repair the damaged drain, install a new drain and make permanent repairs to the road. We are still waiting for quotes to repair potholes.
- **5. YOUTH PROGRAM:** Commissioner Schachner thanked new Beach Commissioner von Oiste and Youth Program Director Samantha Abelson for getting the program up and running.

- **4. Motion** by Trustee Gernaey, seconded by Trustee Musto to transfer \$9,999 from the Capital Fund to the General Fund for the purchase of the lifeguard trailer. Motion carried.
