I. MINUTES of April meeting were accepted as read.

IV. Report of the Mayor:

- The Village has reached an understanding with Yuri Farber for the sale of about ½ acre of Village property adjacent to his for the amount of \$150,000. The property is about 26' wide and 600' long. As part of the agreement, he will also re-vegetate the top of the bluff to keep it stable.
- All residents have been invited to a dinner at the circle on June 7 to thank the Beautification Committee for their dedication and hard work over the last several years

VI. COMMISSIONER'S REPORTS:

1. **Beach:** Commissioner Knapp reported about 5 more families have signed up for cabanas this season. Cabanas will start going up the first week of June and the beach should be up and running by July 1. A resident questioned the lighting at the beach during the overnight hours, saying it was a form of light pollution. Sheila explained the lights are needed to defer vandalism and will be needed for the new security cameras.
2. **Buildings:** Commissioner Geelan reported painting of the interior of the community center has been completed and he is in the process of getting estimates for energy efficient windows. Youth Program Commissioner Françoise Schachner asked if Commissioner Geelan could look at the door of the arts & crafts shack at the beach, as it is in disrepair and may need replacing.
3. **Constabulary:** Commissioner Sandak reported the "men in orange" seen in the Village this week were inmates from the Suffolk County Sheriff's Dept. training program. They worked on Upper & Lower Devon, Sts. Orchard & Cliff, Bell Circle & Buena Vista and at the end of Cliff Road, cleaning out dead/downed trees and vines, saving the Village an estimated \$60,000. Some residents commented they were not comfortable having inmates working in the Village. Commissioner Sandak assured them that they are not hardened criminals; they are serving time for offenses such as DUI, nonpayment of child support or nonpayment of traffic tickets. They are scheduled to come back again next week. Discussion followed and it was decided the residents should be notified by email when they are scheduled to return.
Regular monthly report: In April there were 36 calls for service, including 13 emergencies. There were 738 house checks and 69 summonses were issued. Our burglary rate remains about zero, while surrounding areas have found it climbing.

4. **Parks:** Trustee Sampogna reported a parks and landscaping steering committee has been set up to work with the contracted landscaper and the beautification committee. The post & rail fence at the park is being replaced.
5. **Roads:** Commissioner Raso reported we are getting estimates for the repaving of portions of Park Lane & Alta Vista and pothole repairs will be done in a few weeks. We will look into the drainage problem on Bell Circle.
6. **Youth Program:** Commissioner Schachner reported the registration letters went out at the end of April and registrations are coming in. The program starts on July 2.
7. **Cable/Technology:** No report
8. **Harbor Management:** Commissioner Knapp reported the Town of Brookhaven is considering Privatizing the marina. The Town is also now charging \$25 for parking stickers.
9. **Belle Terre Community Association:** Upcoming events: Boating Safety class this Saturday, Gourmet Dining Club Fish & Chips dinner, June 2, July 4th party at the beach, July 21 Garden Tour, lobster bake in August.
10. **Conservation:** No report.
